YEAR END REPORT FROM KLEIN HALL PROGRAM SUPERVISOR MIKE HENKE

This report is being published to share information about the homeless veteran's program (not shelter) at Klein Hall in Chippewa Falls. The program is supported financially from a grant from the USDVA, the Wisconsin Department of Veterans Affairs is the grant recipient. Facility operations are performed by Lutheran Social Services as the contractor for the State of Wisconsin.

Klein Hall is a 48 bed facility located near the campus of the Veterans Home in Chippewa Falls. The physical address of Klein Hall is 2820 East Park Avenue, Chippewa Falls. The program is eligible to federally recognized veterans eligible for federal benefits. For those veterans that are not eligible for the program, we advocate for them into available State VA programs and/or community-based programs that they are eligible for.

Having a 48 bed program in Western Wisconsin is beneficial to our region in the state. There is only one larger program in Wisconsin which is a 76 bed facility in downtown Milwaukee. And the nearest facility to Klein Hall in Wisconsin is Green Bay.

Klein Hall chartered in December of 2008, since that time, we have serviced hundreds of veterans with VA benefits, job training, and permanently housed back into their communities. We have conducted 46 new intakes as of December 7th during 2022. Overall, in 2022 we have provided services for 76 homeless veterans. During my administration since May of 2017, I am proud to have conducted intakes on 260 homeless veterans offering them safe and sober living while we identify whole health solutions which may have led to their homelessness.

Our staff includes a team of 18 with a mixture of commitment. Eight associates are paid employees of Lutheran Social Services, three LSS registered volunteers, two senior citizens assigned here through the Senior Community Service Employment Program (SCSEP) as a grant from workforce development, and five contracted security personnel from Permar Security. Our team is made up of 39% veterans. Of those veteran staff members, six were retired and felt a need to serve again on this mission of ending veteran homelessness. We are veterans healing veterans.

We truly appreciate the support of your organization, without it, it is unlikely that we would be able to continue this mission. I would like to thank you for all that you do for us, which ensures we can continue on the forefront of ending veteran homelessness. Direct support of our program can be directed with donation of Kwik Trip fuel only gift cards, Walmart gift cards, Farm & Fleet gift cards, monetary donations (checks) made out to Feed My People Food for supporting meals, or checks drafted to Lutheran Social Services restricted to services at Klein Hall.

Welcome home and thank you for your service! And thank you for supporting this needed program providing services, warm meals, and a bed for our vulnerable veterans.
