EMPLOYMENT

USERRA: The Uniformed Services Employment and Reemployment Rights Act protects servicemembers' reemployment rights when returning from a period of service in the uniformed services, including the reserves or National Guard, and prohibits employer discrimination.

- ☐ Covers all uniformed services
- ☐ Honorable, medical, or entry level separation
- ☐ Notify employer prior to deployment
- ☐ No > 5-years cumulative service or special circumstances
- ☐ Timely reapplication and report for civilian work

Return to Employment: A servicemember who is employed is entitled to the rights and benefits (employer provided & statutorily mandated) that they would have attained if they remained employed.

Veteran's Preference: Veterans who are disabled or who served on active duty are entitled to preference over non-veterans in Wisconsin & federal government hiring and retention during reductions-in-force.

Unemployment Compensation for Ex-Servicemembers (UCX): Members of the military leaving active duty discharged under honorable conditions unable to find employment may be eligible for UCX.

DISABILITY

VETERAN'S DISABILITY BENEFITS

Benefits are paid to veterans who have injuries or diseases that occurred while on active duty, or were made worse by active military service. Benefits are also paid to certain veterans disabled from VA health care. These benefits are tax-free. Voc. Rehab also available.

PROTECTION IN LAWSUITS

Under Servicemembers Civil Relief Act [SCRA], servicemember [SM] may request a 90 day stay in civil proceedings if:

- ☐ Military service materially affects SM ability to appear
- ☐ Lists date when SM will be available to appear
- ☐ Statement from SM's commanding officer that military duty prevents appearance & leave is not authorized.

CONSUMER PROTECTION (SCRA)

INSURANCE

Commercial Life Insurance: Upon application, a SM may have ins. premiums and interest guaranteed during service & 2yrs thereafter.

Health insurance: Must be reinstated upon application after duty.

Professional liability insurance: Reinstated w/o premium increase.

LEASES, CONTRACTS & MORTGAGES

Automobile leases: May be terminated upon date of military orders. Lease obligation ends last day of month after written notice provided.

Installment Contracts: No repossession without court order. Proceedings may be stayed by court upon motion by the servicemember.

Mortgages: No foreclosure without court order. Proceeding may be stayed by court or obligation adjusted to preserve parties interest.

Storage Liens: No foreclosure without court order. Proceeding may be stayed by court or obligation adjusted to preserve parties interest.

FINANCIAL PROTECTIONS

6% Interest Cap: An interest-bearing obligation or liability incurred by servicemember *before* service shall not bear interest at rate >6%.

- ☐ Servicemember must provide written notice to creditor
- ☐ Effective on date of order to active duty
- ☐ Interest > 6% rate is forgiven up to 6mos. after service
- ☐ Applies to credit cards (open or closed credit)

Credit Report: No adverse impact for invoking financial protections.

Consumer Credit: Military Lending Act caps interest rate for payday, car title & refund anticipation loans (NOT credit cards), for *active* military at 36%, including all fees. No mandatory arbitration or renewals.

HOME LOANS

USVA Home Loan: VA loan guarantee assists SMs, veterans, & un-remarried surviving spouses obtain homes or condos, refinance mortgage, or energy improvements. Need Certificate of Eligibility. VA guaranty 25% of VA loan limit for SM/vet with full entitlement.

WDVA Home Loan: Wisconsin offers a state veterans home loan program (the Primary Mortgage Loan), different from the USVA.

☐ Purchase, construction, or improvement of a single family home

☐ Purchase of certain existing 2 to 4-unit owner occupied residential property

WDVA Home Improvement Loan Program: Wisconsin veterans can borrow up to 90% of home equity for home improvements.

RENTAL & LEASE PROTECTIONS

Eviction: Upon motion, court must stay proceedings for 90 days for servicemembers on active duty and their dependents.

Residential Leases may be terminated on date of military orders. Upon written notice, lease ends 30 days after next rental payment.

FAMILY LAW

Affidavit of Military Service: Must be filed in any civil action or alert court of servicemember's military status.

Military Retirement Pay: Uniformed Services Former Spouses' Protection Act allows state courts to treat military retired pay as pension in divorce actions. Spouse must be married for 10 years active duty. Health & commissary benefits continue if married 2 years.

Family & Child Support: Servicemembers may not use military service to evade family support obligations. Military will honor court orders or set minimum standards in absence of order.

CITIZENSHIP & NATURALIZATION

USCIS Military Immigration Help Line: (877) 247-4645

During peacetime, active-duty immigrants may apply for US citizenship w/o physical presence in US if served honorably for 1 year. Are Legal Permanent Residents, and apply while serving or w/i 6 months of discharge.

During hostilities may apply immediately if admitted as a LPR at the time of enlistment or induction were physically present in US.
